Leaving a Gift in your Will to the Geelong Community Foundation is a really meaningful way to ensure that your legacy lives on in the community that we all love.

By consolidating, investing and growing donations and Gifts in Wills, we are building a long-term, reliable funding stream for the wellbeing of future generations of our community.

As grants are only made from the income of the Foundation corpus, your gift will have lasting benefits, effectively giving forever. These grants address local key impact areas such as education, health, aged care, youth, community wellbeing, family support and the environment.

Of course, you will want to look after family first, but the good news is that including the Geelong Community Foundation in your Will is just as easy as providing for your loved ones. It can be as much, or as little, as you want, it just needs to be meaningful to you.

There are several options when giving: Your gift can be made during your lifetime as a one-off donation, over a period of time, or provided for in your Will as a bequest – or a combination of these options. Gifts made during a donor's lifetime are tax deductible.

A Gift in your Will creates a Sub Fund in your family name. These are recorded in the Foundation's Annual Report, unless anonymity is requested. Friends and family can also add to this Sub Fund at any time. Gifts to the Geelong Community Foundation are held in trust by the Foundation under terms agreed by you.

You have the power to shape a better future for our region and to strengthen our community.

A Gift in your Will, of any size, makes a significant difference.

How do I include the Geelong Community Foundation in my Will?
